

## Minutes

The Respiratory Care Advisory Committee of the Board of Medical Licensure and Supervision met on November 28, 2023. This regular meeting was held consistent with the Oklahoma Open Meeting Act. Advance notice of this meeting was transmitted to the Oklahoma Secretary of State on November 22, 2022, and posted on the Board's website on November 26, 2023, at 7:36 PM pursuant to 25 O.S. § 311(A)(9).

Mr. Grantz, having noted a quorum, called the meeting to order at 11:30 AM. Barbara Smith called roll to establish the quorum on the record.

Following review, Ms. Beard moved to approve the minutes of August 15, 2023, as written. Ms. Ayala seconded the motion and the vote was unanimous in the affirmative.

Ms. Smith advised that due to the expiration of Ms. Crouch's term on the committee, the role of Committee Vice-Chair is currently vacant. The law governing committee functions allows for elections in odd-numbered years. Ms. Beard moved to nominate Dawn Ayala to serve as Committee Vice-Chair. Prior to receiving a second on the motion, Ms. Ayala moved to nominate Kelly Hennessey to serve as Committee Vice-Chair. Ms. Hennessey respectfully declined the nomination. Ms. Ayala accepted her nomination to serve as Committee Vice-Chair. Ms. Hennessey seconded the motion of Ms. Beard and the vote was unanimous in the affirmative for Ms. Ayala to serve as Committee Vice-Chair.

**HILLARY BANKS-MOUSHON** appeared virtually in support of her application for Respiratory Care Practitioner licensure. She last practiced in July of 2016 and her application is complete. She previously appeared before the Committee in November of 2021 and was given committee recommendations at that time which she did not complete. The applicant stated that

she has a position waiting for her at St. Francis, Tulsa, NICU. Following discussion, Ms. Beard moved to recommend approval of the application with completion of 30 days of direct supervision with a satisfactory report from the supervisor to be provided at the conclusion thereof. Ms. Ayala seconded the motion and the vote was unanimous in the affirmative.

**LEZA BOONE** appeared personally in support of her application for Respiratory Care Practitioner licensure. Her application is incomplete. She appeared before the Committee in May of 2022 and it was recommended her application be approved by endorsement at that time. However, it was then determined she has not had any hands-on practice since December of 2021. She advised the Committee that she works as a respiratory therapist in Texas on an as-needed basis. Following discussion, Ms. Beard moved to recommend approval of the application pending completion of the file. Ms. Tenney seconded the motion and the vote was unanimous in the affirmative.

**JACLYN CARTER** appeared personally in support of her application for Respiratory Care Practitioner licensure. Her Oklahoma license expired in September of 2018 and that is the time she last practiced. Her file is incomplete. The applicant stated she let her license lapse to stay home with her young children. Following discussion, Ms. Beard moved to recommend approval of the application pending completion of the file to include passing the National Board for Respiratory Care entry-level examination and completion of direct supervision for a period of 90 days with a satisfactory report from the supervisor provided at the conclusion thereof. Ms. Ayala seconded the motion and the vote was unanimous in the affirmative.

**BOSTON DAVIS** appeared virtually in support of her application for Respiratory Care Practitioner licensure. Licensing documentation showed that she last practiced in March of 2021 and her application is not complete. The applicant stated she has been working for a durable medical equipment company in Texas setting up pediatric equipment and she is now working with equipment for adults. The applicant explained that she sets up patients on ventilators when they return home and she also provides oxygen and medication per doctor's orders. She also educates the patient on various at-home therapies. She is still working with ventilators, just not in a hospital setting. She also stated that she worked on an as-needed basis providing hands-on care until August of 2021. Following discussion, Ms. Beard moved to recommend approval of the application pending completion of the file. Ms. Tenney seconded the motion and the vote was unanimous in the affirmative.

**JANET HOPKINS** appeared virtually in support of her application for Respiratory Care Practitioner licensure. Her file is incomplete. Her license lapsed May of 2023 and she last practiced December of 2022. She is not currently licensed in any other state. Ms. Hopkins stated she has completed 30 CEUs within the last two years. Following discussion, Ms. Tenney moved to recommend approval of the application pending completion of the file to include completing 12 CEUs. Ms. Ayala seconded the motion and the vote was unanimous in the affirmative.

**KIMBERLY LAMB** appeared virtually in support of her application for Respiratory Care Practitioner licensure. Her application is incomplete. She last practiced hands-on therapy in 2007 and she is currently licensed in Missouri. The applicant stated that, since the lapse of her

license, she has worked primarily in a sleep lab and for the past six years she has been working with a company providing monitoring during surgeries. She has kept her Missouri license and National Board for Respiratory Care credentials current and is considering returning to respiratory therapy rather than continuing in the surgical field. Following discussion, Ms. Ayala moved to recommend approval of the application pending completion of the file to include 90 days of direct supervision with a satisfactory supervisor's report provided at the conclusion thereof. Ms. Hennessey seconded the motion and the vote was unanimous in the affirmative.

**TERESA LEE** did not appear in support of her application for Respiratory Care Practitioner licensure. Ms. Ayala moved to table the application pending a personal appearance before the Committee. Ms. Beard seconded the motion and the vote was unanimous in the affirmative.

**VANESSA REYES** did not appear in support of her application for Respiratory Care Practitioner licensure. Ms. Ayala moved to table the application pending a personal appearance before the Committee. Ms. Tenney seconded the motion and the vote was unanimous in the affirmative.

**LINDSAY SANDERS** appeared in support of her application for Respiratory Care Practitioner licensure. Her Oklahoma license lapsed November 30 of 2022 and she last practiced in November of 2022. Currently, her application is incomplete. The applicant stated that she took a break from respiratory care after Covid and she has not completed any CEUs in the last two years. Following discussion, Ms. Ayala moved to recommend approval of the application pending completion of the file to include 12 CEUs. Ms. Tenney seconded the motion and the vote was unanimous in the affirmative.

**KAMBRI ST. JOHN** appeared personally in support of her application for Respiratory Care Practitioner licensure. She last practiced in December of 2021. Her application is complete. The applicant stated she let her license lapse due to needing a break after Covid. She plans to work at the hospital in Woodward, Oklahoma, after she is licensed. Following discussion, Ms. Beard moved to recommend approval of the application. Ms. Ayala seconded the motion and the vote was unanimous in the affirmative.

**DEBBY WRIGHT** appeared personally in support of her application for Respiratory Care Practitioner licensure. Her application is complete. She appeared in April of 2017 and was given a recommendation to pass the National Board for Respiratory Care exam at that time which she did. Her file went into an Oklahoma Tax Commission hold and she was unable to renew her license. She has completed some CEUs and advised that she previously worked for LifeShare as a bedside organ recovery coordinator. Currently, she has a job pending at St. John's in Tulsa. Following discussion, Ms. Beard moved to recommend approval of the application pending completion of 22 days of direct supervision with a satisfactory supervisor's report provided at the conclusion thereof. Ms. Ayala seconded the motion and the vote was unanimous in the affirmative.

Next, the Committee reviewed applications for licensure. Ms. Beard moved to recommend approval of the incomplete application(s) for Provisional Respiratory Care

Practitioner licensure as identified on the page(s) attached as *Attachment #1* hereto pending completion of the file(s). Ms. Ayala seconded the motion and the vote was unanimous in the affirmative.

Ms. Beard moved to recommend approval of the complete application(s) for Provisional Respiratory Care Practitioner licensure as identified on the page(s) attached as *Attachment #1* hereto. Ms. Ayala seconded the motion and the vote was unanimous in the affirmative.

Ms. Beard moved to recommend approval of the incomplete application(s) for Respiratory Care Practitioner licensure as identified on the page(s) attached as *Attachment #1* hereto pending completion of the file(s). Ms. Ayala seconded the motion and the vote was unanimous in the affirmative.

Ms. Beard moved to recommend approval of the complete application(s) for reinstatement of Respiratory Care Practitioner licensure as identified on the page(s) attached as *Attachment #1* hereto. Ms. Ayala seconded the motion and the vote was unanimous in the affirmative.

Ms. Tenney moved to recommend approval of the incomplete application(s) for reinstatement of Respiratory Care Practitioner licensure as identified on the page(s) attached as *Attachment #1* hereto pending completion of the file(s). Ms. Ayala seconded the motion and the vote was unanimous in the affirmative.

Ms. Tenney moved to recommend approval of the complete application(s) for Respiratory Care Practitioner licensure as identified on the page(s) attached as *Attachment #1* hereto. Ms. Beard seconded the motion and the vote was unanimous in the affirmative. Ms. Ayala seconded the motion and the vote was unanimous in the affirmative.
